Re: Incoming Material Receiving Policy

Homeland Energy Solutions is asking for your assistance in implementing the following incoming material receiving policy. These procedures ensure the quality and safety of our incoming material supply.

Effective January 20, 2011, Homeland Energy Solutions will require that the last material hauled in bulk equipment prior to the delivery of raw materials to Homeland Energy Solutions not include certain materials (as listed below). If any of these materials were hauled on the prior load, the load to Homeland Energy Solutions will be rejected. Note: This policy applies regardless of whether a wash out of the equipment was conducted.

All drivers will be required to sign a Certificate of Compliance form to verify that the current load hauled and prior load hauled did not contain prohibited protein products or other hazardous materials.

The list of prohibited protein product and hazardous material is as follows:

Prohibited Animal Protein Products (PAPPS) of Ruminant Origin

- Animal digest
- Animal liver
- Bone meal cooked
- Bone meal steamed
- Cooked bone marrow
- Dried meat solubles
- Fleshings hydrolysate
- Food Processing Waste

- Glandular meal & extracted glandular meal
- Hydrolyzed hair
- Hydrolyzed leathermeal
- Meat
- Meat & bone meal (ruminant)
- Meat & bone meal tankage
- Meat by-products
- Meat meal

- Meat meal tankage
- Meat protein isolate
- Mechanically separated bone marrow
- Pet food
- Restaurant Food Waste
- Stock
- Beef Tallow with >0.15% impurities
- Unborn calf carcasses

Hazardous Products Not Approved For Use in Animal Feeds

Ashestos

- Carbon black
- Crushed or broken glass or fiberglass

Unapproved fertilizers:

- Ferrous metal shavings
- Ground rubber
- Industrial chemicals
- Municipal waste

Non ferrous metals and materials

Ammonium Nitrate phosphate

- Powdered Metal
- Scrap Metal

All other products not approved by the FDA or listed unacceptable for animal feed in the American Association of Feed Control Officials Manual.
